NOW, THEREFORE, the Assignor hereby agrees as follows:

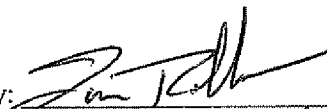

2. Miscellaneous. If any provision of this Assignment shall be held by a court of competent jurisdiction to be illegal, invalid or unenforceable, the remaining provisions shall remain in full force and effect.

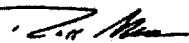
