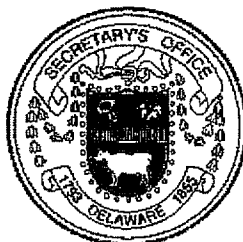

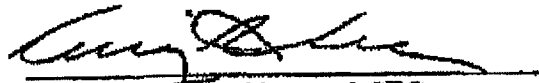
1. He is the President and Chief Executive Officer of AgiLight Holdings, Inc., a Delaware corporation.
