NOTICE OF TRADEMARK LICENSE

This NOTICE OF TRADEMARK LICENSE (this "Notice"), effective as of May 15, 2008, is entered into by and between Carrier Commercial Refrigeration, Inc ("CCR"), a corporation duly organized and existing under the laws of Delaware; and BA Acquisition, Inc. ("BAA"), a corporation duly organized and existing under the laws of Delaware (each a "party" and collectively "the parties"). Capitalized terms used and not otherwise defined in this Notice have the meanings given to them in that certain RETAINED SHARED TRADEMARK LICENSE AGREEMENT, dated as of May 15, 2008 (the "License Agreement"), by and between CCR and BAA.

WITNESSETH:

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of May 2, 2008 (the "APA"), by and among CCR, BAA and Ali Group North America Corporation, a Delaware corporation ("Ali Group NA"), CCR is required to grant a license to BAA in and to certain trademarks particularly set forth in the attached Exhibit A.

WHEREAS, pursuant to the License Agreement, CCR has granted a license to BAA in and to the trademarks particularly set forth in the attached Exhibit A.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CCR and BAA hereby agree as follows:

1. The parties hereby confirm that CCR has granted a license to BAA in and to certain trademarks particularly set forth in the attached Exhibit A (the "Trademark Rights").
2. CCR further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further lawful documents as BAA may from time to time reasonably request to effect fully the License Agreement and to permit BAA to be duly recorded as a licensee of the Trademark Rights.
