**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE dated as of June 13, 2008 (this "Release"), is made by LaSalle Bank National Association, a national banking association ("Secured Party"), in connection with that certain Second Amended and Restated Intellectual Property Security Agreement dated as of July 31, 2007 ("Security Agreement") and recorded in the records of the United States Patent and Trademark Office at Patent Reel 019628, Frame 0958, at Trademark Reel 3593, Frame 0720, among Advantis Medical, Inc., an Indiana corporation, Avalign Technologies, Inc., a Delaware corporation, Instrumed International, Inc., a Delaware corporation, Nemcomed, Inc., an Ohio corporation, and Nemcomed FW, LLC, an Indiana limited liability company (collectively, the "Debtors") and Secured Party.


WHEREAS, pursuant to the Security Agreement, the Debtors granted to the Secured Party a security interest in certain of the Debtors' patents, trademarks and other intellectual property (the "Intellectual Property").

WHEREAS, the Secured Party wishes to: (i) release all liens and security interests granted to the Secured Party under the Security Agreement covering the Intellectual Property; (ii) restore all right, title and interest in and to the Intellectual Property to Debtors; and (iii) dissolve any and all liens and encumbrances in respect of the Intellectual Property granted under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Intellectual Property, and discharges, quit claims and relinquishes unto the Debtors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Intellectual Property under the Security Agreement.
