("RAD") and the Company, (ii) the Intellectual Property Security Agreement, dated as of August 29, 2006, between RAD and the Company, (iii) the Collateral Assignment of Trademarks, dated as of August 29, 2006, between RAD and the Company and (iv) the Collateral Assignment of Copyrights, dated as of August 29, 2006, between RAD and the Company (collectively, the "Security Documents") to the security and lien interests in the RAD trademarks listed on Schedule 1 attached hereto and the RAD copyrights listed on Schedule 2 attached hereto (such trademarks and copyrights, the "Collateral").

Each of the undersigned Members further agrees to appoint Good Partners Consumer Fund I, L.P., as its collateral agent with respect to the Collateral under the Security Documents, and Good Partners Consumer Fund I, L.P. hereby accepts such appointment.

This Assignment has been made under, and will be governed by, and construed and enforced in accordance with, the laws of the State of New York. This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same instrument. Delivery of a copy of this Assignment bearing an original signature by facsimile transmission or by electronic mail in "portable document format" form shall have the same effect as physical delivery of the paper document bearing the original signature.
