ARTICLES OF CORRECTION

OF

E-Z GARD INDUSTRIES, INC.

The undersigned, being the Chief Executive Officer of E-Z Gard Industries, Inc., a Minnesota corporation, hereby provides the following information pursuant to Minn. Stat. §5.16,

Subd. 2:

1. The instrument to be corrected was filed by Jon D. Kittelsen, the incorporator of E-Z Gard Industries, Inc. Mr. Kittelsen is no longer a shareholder, officer or director of E-Z Gard Industries, Inc.
2. The instrument to be corrected is the Articles of Incorporation of E-Z Gard Industries, Inc., which was filed with the State of Minnesota on April 26, 1991.
3. The inaccuracy, error or defect in the instrument to be corrected is the inclusion of the hyphen in the corporation's name. The name should have been EZ Gard Industries, Inc. rather than E-Z Gard Industries, Inc. The corporation has generally excluded the hyphen in conducting its business.
4. The corrected form of the instrument to be corrected is as follows:
