ASSIGNMENT AGREEMENT

WHEREAS, **Air Products Polymers, L.P.** ("APP"), a Delaware limited partnership is listed as the owner of a certain US trademark registration for the trademark "FLEXBOND", associated with acrylic and vinyl ester polymer emulsions used in the further manufacture of goods in the coating products and adhesives industries; and

WHEREAS, APP has subsequently been reorganized into **Wacker Polymers, L.P.** ("WPLP") which now owns the US trademark registration for the trademark "FLEXBOND".

WHEREAS, **Air Products and Chemicals, Inc.** ("AIR PRODUCTS"), a Delaware corporation, and **Wacker Chemie AG**, a corporation organized under the laws of the Federal Republic of Germany ("WACKER") had entered into a Distribution and Purchase Agreement dated 7 December 2007 ("DPA") whereby AIR PRODUCTS and WACKER have agreed, among other things, for the transfer to AIR PRODUCTS of the Distributed Businesses as defined in the DPA.

WHEREAS, Section 2.10(a) (ix) of the DPA requires that certain intellectual property rights including the FLEXBOND trademark registration be conveyed to AIR PRODUCTS.

WHEREAS, AIR PRODUCTS desires to acquire the entire right, title and interest in the "FLEXBOND" trademark, including such registration.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged. WPLP does by these presents assign, convey, transfer and delivery to AIR PRODUCTS, its successors and assigns, the entire right, title and interest, worldwide, in and to the aforesaid trademark, including such registration, and in particular, the following:

U.S. Trademark Registration No. 2,479,885 "FLEXBOND"

together with the goodwill of the business associated with said trademark, effective as of the date set forth herein.

WPLP agrees with AIR PRODUCTS to assign, sell, execute and deliver, or cause to be assigned, sold, executed and delivered, and to do or make or cause to be done or made, upon reasonable request by AIR PRODUCTS and AIR PRODUCTS' expense, any and all instruments, papers, deeds, acts or things, supplemental, confirmatory or otherwise, as may be reasonably required by AIR PRODUCTS for the purpose of or in connection with more effectively vesting in AIR PRODUCTS or evidencing the vesting in AIR PRODUCTS of the aforesaid U.S. trademark registration for the trademark "FLEXBOND".

IN WITNESS WHEREOF, WPLP and AIR PRODUCTS have caused this Assignment Agreement to be executed this __ day of April 2008 by their duly authorized officers.
