## GLOBAL ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

This Global Assignment of Intellectual Property Rights Agreement (the "Assignment") is executed and delivered as of June 9, 2008, by Constellation Wines U.S., Inc., a New York corporation ("Seller"), pursuant to that certain Asset Purchase and Sale Agreement dated as of June 9, 2008 (the "Agreement"), by and between Seller and Eight Estates Fine Wines, LLC, a Delaware limited liability company ("Buyer"), whereby Buyer is a successor to a portion of the business of the Seller to which the Intellectual Property pertains. Capitalized terms used in this Global Assignment of Intellectual Property Rights and not otherwise defined herein shall have the respective meanings assigned to them in the Agreement.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby sells, transfers, assigns, and conveys to Buyer, all of Seller's right, title and interest in and to the Intellectual Property, including but not limited to the applications and registrations set forth in Exhibit A attached hereto and incorporated herein by this reference, and including all rights to sue for past, present and future infringement thereof, together with the goodwill of the business connected with such Intellectual Property.

This Assignment is executed pursuant to and is subject to all of the terms and conditions of the Agreement, and shall not limit in any way the rights of Buyer or Seller under or relating to the Agreement or any documents or instruments executed pursuant thereto or in connection therewith. This Assignment shall be binding upon Seller and its permitted successors and assigns and shall inure to the benefit of Buyer and its permitted successors and assigns.
