## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment ") is effective as of June 16, 2008 by International Processing Corporation, a Georgia corporation ("Assignor"), in favor of Scope Products, Inc., a California corporation ("Assignee"), with reference to the following facts:

### RECITALS

Assignor is the owner of the trademark "DBP" (the "Trademark"), registered on the Principal Register of the United States Patent and Trademark Office on September 1, 1964 (Reg. No. 776,282.) Assignor desires to sell, transfer and assign its rights, title and interest in and to the Trademark and all goodwill associated with the Trademark to Assignee. Assignee desires to acquire the Trademark and all goodwill of the business associated with the Trademark and all rights in the Trademark.

### AGREEMENT

For good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all rights, title and interest in and to the Trademark, together with all the goodwill of the business symbolized by the Trademark.

Assignor warrants to Assignee that Assignor is the owner of the Trademark and that Assignor is conveying to Assignee all of Assignor's right, title and interest in the Trademark, free and clear of all liens, security interests and encumbrances.

The Commissioner of Patents and Trademarks is requested to amend its records to reflect the assignment of the Trademark to Scope Products, Inc., a California corporation, the assignee.
