Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Amendment to the existing Articles of Incorporation being effected hereby is to delete Article I of the Articles of Incorporation and to substitute in its place the following:

ARTICLE I. NAME

The name of this company is Gold Standard, Inc. (the "Company" or the "Corporation").


2. This amendment to the Articles of Incorporation was approved by written consent of the stockholders through the following voting groups:
