
The Assignor further assigns to the Assignee all rights to sue for and receive all damages occurring from past infringements of the Trademarks.



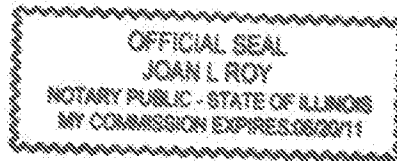
