**TRADEMARK ASSIGNMENT FROM
CAPAM ENTERPRISES, INC. TO AMT GROUP, LLC**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns and transfers to Assignee the Assignor's entire right, title, and interest in, to and under the Marks and the registrations therefor, together with the goodwill of the business connected with the use of and symbolized by the Marks, and the portion of Assignor's business to which the Marks pertain, which business is ongoing and existing. All rights and privileges associated with the Marks, including the right to sue for and receive all damages from any past or future infringements or other violations of the Marks, will be held and enjoyed by the Assignee, its successors, assigns and other legal representatives. Assignor represents and warrants to Assignee that it has made continuous use of the Marks in connection with the goods and/or services recited in the Registrations at least since the date of first use in commerce recited in the Registrations.
