WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademark, including all goodwill associated therewith;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, conveys and assigns to Assignee all of Assignor's legal and beneficial right, title and interest in and to the Trademark, together with the goodwill of the business associated with the Trademark.




This Assignment shall be governed by the internal laws of the Commonwealth of Pennsylvania, United States, without regard to principles of conflicts of law.
