TRADEMARK ASSIGNMENT

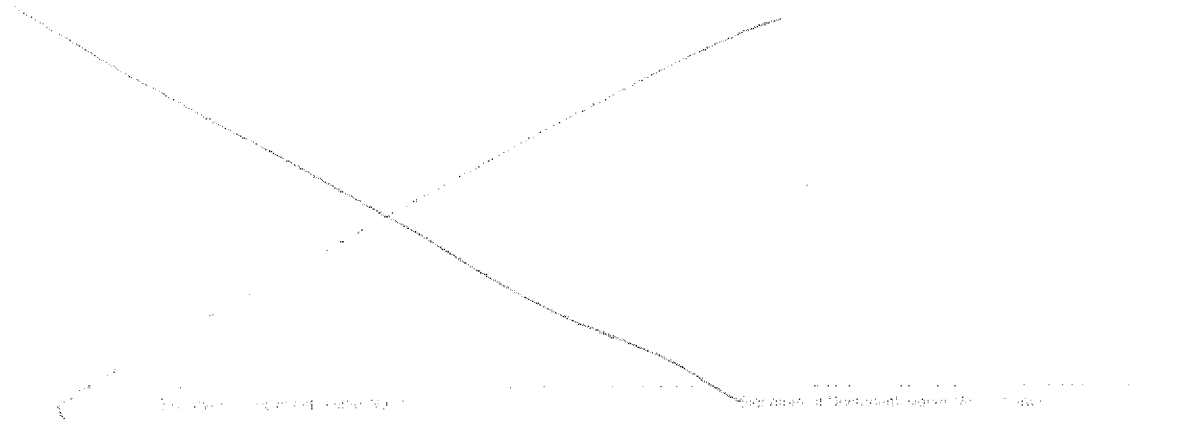
