RELEASE OF SECURITY INTEREST IN TRADEMARKS AND LICENSES

WHEREAS, CUSA AWC, LLC ("Debtor"), with its principal place of business at 5430 LBJ Freeway, Three Lincoln Centre, Suite 1075, Dallas, Texas 75240 granted a security interest in and lien upon certain trademarks, trademark applications, licenses and related rights to Bank of America, N.A. 1. releases and reassigns to Debtor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in the trademarks, trademark applications and licenses more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.



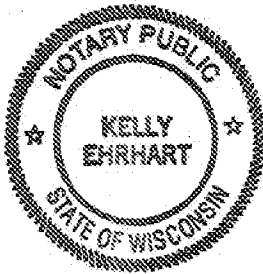
