CONFIRMATORY TRADEMARK ASSIGNMENT


THIS ASSIGNMENT is made this date by and between Frank R. Wollman, of 11807 Saddlerock Road, Silver Spring, MD 20902 (hereinafter referred to as "Assignor"), and A.V. Imports, Inc., a Maryland corporation, whose address and principal place of business is 6450 Dobbins Road, Columbia, MD 21045 (hereinafter referred to as "Assignee").

WHEREAS, Assignor has adopted and used, and is the owner of the trademark SANTINI [& DESIGN] and the federal registration therefor, No. 1,493,426 dated June 21, 1988 (hereinafter referred to as the "ASSIGNED MARK"); and

WHEREAS, on or about August 15, 1988, Assignor incorporated the business of Assignee, and did assign the ASSIGNED MARK to Assignee, as successor to the ongoing and existing business of Assignor to which the ASSIGNED MARK pertains, but no formal assignment in a form recordable in the U.S. Trademark Office was executed and/or can be found, and the parties now desire to execute this Confirmatory Trademark Assignment to confirm and formally record the actual assignment of the ASSIGNED MARK in the Assignment Records of the U.S. Trademark Office.

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration previously paid by Assignee to Assignor, the receipt of which is hereby acknowledged, said Assignor does hereby sell, assign, set over and transfer to said Assignee, *nunc pro tunc* as of August 16, 1988, all of its right, title and interest in and to the ASSIGNED MARK, and the U.S. registration therefor, together with the goodwill of the business associated therewith, and all statutory and common law rights attaching thereto.
