
WHEREAS Assignor or a related company of Assignor, has adopted, used and is now using the Trademark; and



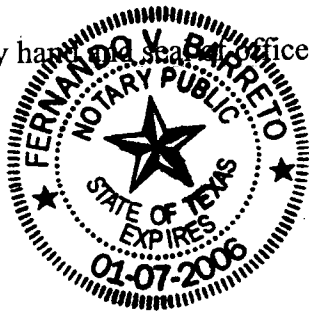

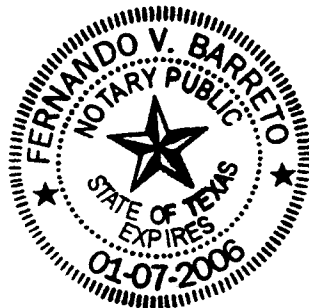
