UNITED STATES TRADEMARK AND SERVICE MARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into as of this 28th day of August , 2002 (the "Effective Date") by and between Hoss's Enterprises, Inc., a Pennsylvania Corporation ("Assignor") and Hoss's Enterprises, Inc., a Delaware Corporation ("Assignee").

RECITALS

A. Assignor is the sole and exclusive owner of the entire right, title and interest in, to and under the United States trademark registration set forth on Schedule A, including variations thereof, and the goodwill of the business associated therewith.

B. Assignee wishes to acquire and Assignor wishes to assign all right, title and interest in and to the Mark together with the goodwill of the business in connection with which the Mark is used.

AGREEMENT

WHEREAS, Hoss's Enterprises, Inc., a corporation duly organized and existing under the laws of the State of Pennsylvania, and having offices at One 764 Plaza, Duncansville, PA 16635, hereinafter referred to as "HEI," is the owner of the Trademark entitled "Hossauce", set forth on Schedule A, in connection with the goods described therein (the "Mark"), together with the goodwill of the business to which the Mark pertains (the "Goodwill"), and a United States Trademark Registration set forth on Schedule A (the "Registration"); and

WHEREAS, Hoss's Enterprises, Inc., a corporation duly organized and existing under the laws of the State of Delaware and having its principal office at 300 Delaware Avenue, Suite 1704, Wilmington, DE, 19801, hereinafter referred to as "Hoss's", is desirous of acquiring the


Mark, together with the Goodwill, and the Trademark Application;

NOW, THEREFORE, for the sum of ten dollars (“\$10.00”), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, HEI has agreed to sell and has sold, assigned, transferred and set over, and by these presents does sell, assign, transfer and set over unto Hoss’s, HEI’s entire right, title and interest in and to the Mark, the Goodwill, and the Registration, to be held and enjoyed by Hoss’s for its own use and benefit, and for the use and benefit of Hoss’s successors, assigns, or other legal representatives, and any renewal issued based upon the Registration, to be used as fully and entirely as such rights would have been held and enjoyed by HEI had this Assignment and sale not been made. HEI requests the Commissioner of Trademarks to record Hoss’s as the assignee and owner thereof.

HEI hereby represents and warrants that its right, title and interest in and to the Mark set forth in Schedule A is free and clear of any liens and encumbrances, that it has full right to assign all of its interests therein, and that it has not executed and will not execute any agreement or other instrument in conflict therewith.

HEI covenants that HEI is the owner of the Mark and the holder of record title to the Registration, that HEI has full power to make this Assignment and that HEI agrees to execute such further assignments and related documents with respect to the Mark, the Goodwill, and the Registration as Hoss’s shall reasonably request.

IN WITNESS WHEREOF, HEI has caused this Assignment to be executed by its proper officers who are duly authorized, this 28th day of August, 2002.




