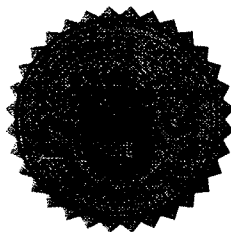

Kuoni, III, as an authorized person of Met-Coil Systems, LLC (the "*LLC*"), to convert the Company to the LLC, under the Delaware Limited Liability Company Act (6 Del. C. § 18-101 et seq.) (the "*LLC Act*"), and the General Corporation Law (8 Del. C. § 101 et seq.) (the "*DGCL*").

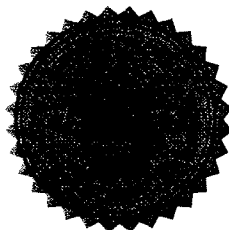


