For purposes of this Agreement "Intangible Property" means all material patents, trademarks, trade names, service marks, logos, copyrights, domain names, including applications therefor, inventions, formulas, methods and processes used by the Company or any of its subsidiaries or affiliates at any time, whether in the past, present or future.

This letter agreement shall be governed by the laws of the state of Florida (without giving effect to any conflicts or choice of laws provisions which would cause the applications of the domestic substantive laws of any other jurisdiction).
