**RELEASE OF MEMORANDUM OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of June 19, 2008, made by The CIT Group/Commercial Services, Inc. ("CIT"), with offices located at 300 South Grand Avenue, Los Angeles, California 90071.

**WHEREAS**, CIT and Burke Industries (Delaware) Inc., (the "Debtor") are parties to a certain Financing Agreement dated as of November 21, 2006 (the "Financing Agreement"), pursuant to which CIT made certain loans and other financial accommodations (the "Loans") to the Debtor.


**NOW THEREFORE**, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

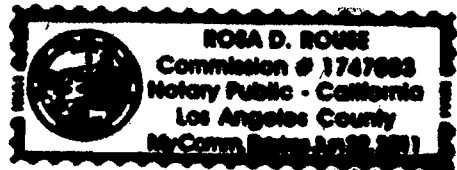
