TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is entered into as of May 16, 2008, by and between Green Bull, Inc., a Kentucky corporation with a place of business at 11225 Bluegrass Parkway, Louisville, Kentucky 40299 ("Assignor"), and Werner Co. ("Assignee").

WHEREAS, Green Bull Loan Acquisition, LLC ("Lender") has designated Assignee to receive this assignment in accordance with the Collateral Transfer Agreement by and between Lender and Assignor, dated May 16, 2008 (the "CTA");

WHEREAS, Lender has agreed not to pursue Assignor for a deficiency judgment under the Assignor's obligations set forth in the Loan Documents (as defined in the CTA) as provided in the Covenant Not to Sue (as defined in the CTA);

WHEREAS, Assignor has adopted, used and is using the trademark GREEN BULL in the United States (the "Trademark"), and is the owner of United States Trademark Application Ser. No. 76/687248, in connection with "Metallic ladders namely aluminum and steel ladders and accessories therefor, namely aircraft maintenance ladder, step ladder, double entry step ladder, platform ladder, shelf ladder, extension ladder, scaffold board, planks, rail systems, extension planks, rolling scaffold, guard rail, outriggers, workstands, drywall cart, warehouse ladder" in class 6, and "Nonmetallic ladders namely fiberglass, wood and synthetic ladders and accessories therefor, namely single step ladders, double entry step ladders, platform ladders, tripod ladders, double section extension ladders, I-beam extension ladder, single section extension ladders, extension-trestle ladder, manhole ladders, shelf ladders, step stools, twin step stools, step-to-straight combination ladders, extension trestle ladders, work stands, billboard ladders, fiberglass ladders, polymeric ladders, accessory shelves for ladders, ladder tie-downs, ladder stabilizers, ladder jacks, articulated ladders, combination ladders, scaffolding, scaffold horses, scaffold platforms, catwalks, work towers, stair towers, deck boards, guard rails" in class 20; and

WHEREAS Assignee has on this date acquired from Assignor certain assets and property used in Assignor's business and is desirous of acquiring the Trademark, and any other registrations and applications for registration of the Trademark owned or held by Assignor, along with the goodwill of the business symbolized by the Trademark.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound,

Assignor hereby sells, assigns and transfers to Assignee all of Assignor's right, title and interest in and to the Trademark, together with any other registrations and application for registration of the Trademark, in and to all income, royalties, damages and payments now or hereafter due or payable with respect thereto and in and to all rights of action arising under the Trademark, all claims for damages by reason of past, present and future infringement of the Trademark and the right to sue and collect damages for such infringement, to be held and enjoyed by Assignee for

its own use and benefit and for its successors and assigns as the same would have been held by Assignor had this assignment not been made, and including the goodwill of the business symbolized by the Trademark.
