CONFIRMATORY ASSIGNMENT

This Confirmatory Assignment is executed by and between Vertellus Specialties Inc., an Indiana corporation located at 300 N. Meridian Street, Suite 1500, Indianapolis, Indiana 46204, U.S.A. ("Vertellus"), and Rutherford Chemicals LLC, a Delaware limited liability company located at 40 Avenue A, Bayonne, New Jersey 07002, U.S.A. ("Rutherford").

WHEREAS, as the result of an Agreement and Plan of Merger (the "Agreement") dated July 10, 2006, Rutherford, did assign and transfer to Vertellus, the entire right, title and interest in the trademark registrations and applications outlined in the attached Exhibit A (the "Marks"), together with the goodwill associated therewith; and

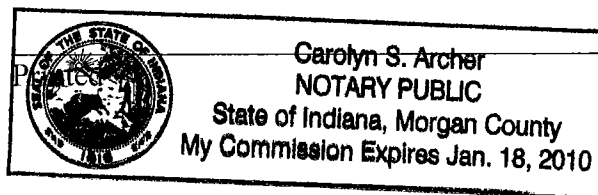

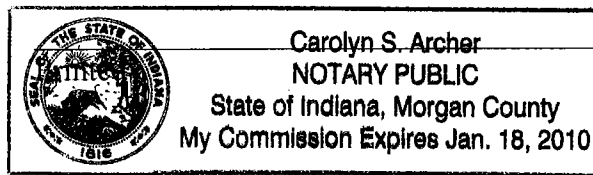
