RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of June 23, 2008 ("Effective Date") by and between **Cooperative Centrale Raiffeisen-Boerenleenbank, B.A. Robabank International, New York Branch**, with an office at 4 Embarcadero, Suite 3200, San Francisco, California 94111 USA ("Secured Parties"), and **Frozsun, Inc.**, a California corporation, with an address at 701 West Kimberly Avenue, Suite 210, Placentia, California 92870 USA and **Sunrise/Frozsun Holdings, LLC**, a Delaware limited liability company, with an address at 701 West Kimberly Avenue, Suite 210, Placentia, California 92870 USA (individually, a "Subsidiary Grantor" and collectively, the "Subsidiary Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement (Trademarks) by and between Subsidiary Grantors and Secured Parties dated May 1, 2003 (the "Trademark Security Agreement"), Subsidiary Grantors granted to Secured Parties a security interest in and to all of Subsidiary Grantors' right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Subsidiary Grantors (collectively, the "Trademarks"), including, without limitation, the United States trademark registrations set forth on the Schedule attached hereto, in each case, together with the goodwill associated therewith and all Proceeds (as defined in the Security Agreement) of any and all of the foregoing;

WHEREAS, Subsidiary Grantors and Secured Parties entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Credit Agreement by and between Subsidiary Grantors and Secured Parties dated May 1, 2003 (the "Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 15, 2003 at Reel 2651, Frame 0267; and

WHEREAS, Subsidiary Grantors has paid all of its outstanding indebtedness to Secured Parties.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Parties hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges and releases any and all security interests it has against the Trademark Collateral.

Secured Parties shall take all further actions, and provide to Subsidiary Grantors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Subsidiary Grantors to more fully and effectively effectuate the purposes of this Release.
