SECOND AMENDED AND RESTATED TRADEMARK, PATENT AND COPYRIGHT
SECURITY AGREEMENT
(First Lien)

THIS SECOND AMENDED AND RESTATED TRADEMARK, PATENT AND COPYRIGHT SECURITY AGREEMENT (this "Agreement"), dated as of June 10, 2008, is entered into by and among each of the Persons listed on the signature pages hereto (each a "Debtor" and collectively "Debtors"), and BANK OF AMERICA, N.A. ("Bank of America"), in its capacity as agent ("Agent") for itself and the Secured Party (as defined below), having an office at 901 Main Street, 22nd Floor, TX1-492-22-13, Dallas, TX 75202, with reference to the following facts:

RECITALS

A. Dorskocil Manufacturing Company, Inc., a Texas corporation ("Borrower"), previously entered into the Amended and Restated Loan and Security Agreement dated as of January 31, 2006 (as heretofore amended, the "Original Loan Agreement"), among Borrower, the lenders party thereto, Bank of America, N.A., as agent and Ableco Finance LLC as term loan B agent, pursuant to which certain credit facilities were made available to Borrower.

B. In connection with the Original Loan Agreement, Aspen Pet Products Holdings, Inc. ("Aspen Holdings") and Aspen Pet Products, Inc. ("Aspen") entered into a Guaranty, dated January 31, 2006, in favor of Bank of America, as agent for the benefit of certain beneficiaries described therein (the "Original Guaranty").

C. In connection with the Original Loan Agreement, Borrower, Aspen Holdings and Aspen entered into an Amended and Restated Trademark and Patent Security Agreement dated January 31, 2006, in favor of Bank of America, as agent for the benefit of the secured party described therein (the "Original Trademark Security Agreement"). The Original Trademark Security Agreement secured, with respect to Aspen and Aspen Holdings, their obligations under the Original Guaranty, and with respect to Borrower its obligations under the Original Loan Agreement and other loan documents entered into in connection therewith.

D. The Original Loan Agreement is being amended and restated by the Second Amended and Restated Loan and Security Agreement of even date herewith, by and among Borrower, the lenders from time to time party thereto (each a "Lender" and collectively, the "Lenders"), Agent, and Bank of America, N.A., as Term Loan B Agent (as such agreement may from time to time be extended, modified, renewed, restated, supplemented or amended, the "Loan Agreement") pursuant to which the Lenders are making certain credit facilities available to Borrower.

E. In connection with the Loan Agreement, Aspen and Aspen Holdings have entered into an Amended and Restated Guaranty of even date herewith, in favor of Agent for the benefit of the beneficiaries described therein (as such agreement may from time to time be extended, modified, renewed, restated, supplemented or amended, the "Guaranty")

which amends and restates (but without novation) the Original Guaranty with respect to obligations owed to the beneficiaries described in the Guaranty.

F. The Loan Agreement provides, as a condition to the availability of the credit facilities described, that Debtors enter into this Agreement, which amends and restates (but without novation) the Original Trademark Security Agreement with respect to obligations owed to Secured Party and to grant security interests to Secured Party as herein provided.

G. The Original Trademark Security Agreement provided for the grant of two separate security interests for the benefit of certain separate sets of lenders. This Agreement is a continuation of the security interest granted thereunder for the benefit of Secured Party. Concurrently herewith Debtors are also entering into a Second Amended and Restated Trademark, Patent and Copyright Security Agreement for the benefit of Term Loan B Agent and the secured parties described therein, which amends and restates (but without novation) the Original Trademark Security Agreement with respect to obligations owed to such Persons.

H. Each Debtor expects to realize direct and indirect benefits as a result of the availability of the aforementioned credit facilities.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Debtors and Secured Party agree as follows:

1. DEFINITIONS. Terms defined in the Loan Agreement and not otherwise defined in this Agreement shall have the meanings given those terms in the Loan Agreement as though set forth herein in full. The following terms shall have the meanings respectively set forth after each:

"Agreement" means this Amended and Restated Trademark, Patent and Copyright Security Agreement, and any extensions, modifications, renewals, restatements, supplements or amendments hereof, including, without limitation, any documents or agreements by which additional Grantors become party hereto.

"Intellectual Property Collateral" means (a) all of Debtors' now existing or hereafter acquired right, title, and interest in and to: all of Debtors' trademarks, trade names, trade styles and service marks; all prints and labels on which such trademarks, trade names, trade styles and service marks appear, have appeared or will appear, and all designs and general intangibles of a like nature; all applications, registrations and recordings relating to the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any State thereof, any political subdivision thereof or in any other countries, and all reissues, extensions and renewals thereof including, without limitation, those trademarks, terms, designs and applications described in Schedule A hereto (collectively, the "Trademarks"); (b) the goodwill of the business symbolized by each of the Trademarks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks; (c) all of Debtors' now existing or hereafter acquired right, title and interest in and to: all of Debtors' interests in any patents, whether foreign or domestic; all applications, registrations and recordings relating to such

patents in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any State thereof, any political subdivision thereof and all reissues, extensions and renewals thereof, including, without limitation, those patents, applications, registrations and recordings described in Schedule B hereto (the "Patents"); (d) all of Debtors' present and future copyrights, rights and interests in copyrights, works protectable by copyright, copyright registrations and copyright applications, whether foreign or domestic, and United States, state and international registrations of the foregoing, and all reissues, extensions and renewals of the foregoing, including, without limitation, those listed on Schedule D hereto (the "Copyrights"), together with all income, royalties, damages and payments now or hereafter due and/or payable with respect to the foregoing; the right to sue for past, present and future infringements of rights in copyrights, all goodwill of Grantors related thereto, and any and all proceeds of any of the foregoing, including, but not limited to, any and all proceeds of licensing thereof; and (e) any and all proceeds of any of the foregoing, including, without limitation, any claims by Debtors against third parties for infringement of the Trademarks, Patents, Copyrights or of any licenses with respect thereto.

"Secured Party" means collectively, (i) Agent, (ii) the First Lien Lenders, (iii) Agent, any First Lien Lender or any Affiliate of any First Lien Lender or Agent who has a Derivative Obligation owing to it, and (iv) Agent, any First Lien Lender or any Affiliate of any First Lien Lender or Agent who has a Product Obligation owing to it, and each of them, and any one or more of them, and their respective successors in interest. Subject to the terms of the Loan Agreement, any right, remedy, privilege or power of Secured Party shall be exercised by Agent.

"Secured Obligations" means, (a) as to Borrower, all Revolving Credit and Term Loan A Obligations of Borrower to Secured Party under the Loan Agreement and other Loan Documents, and (b) as to Aspen and Aspen Holdings, all Guaranteed Obligations (as defined in the Guaranty) of Aspen and Aspen Holdings to Secured Party under the Guaranty, including without limitation, as set forth in Section 2 of the Guaranty, all whether due or to become due, matured or unmatured, liquidated or unliquidated, or contingent or noncontingent, including obligations of performance as well as obligations of payment, and including interest that accrues after the commencement of any bankruptcy or insolvency proceeding by or against any Debtor.

2. SECURITY INTEREST

A. Security Interest in Intellectual Property Collateral. In order to secure the prompt and indefeasible payment and performance of the Secured Obligations, each Debtor hereby grants to Secured Party, a security interest in the Intellectual Property Collateral.

3. WARRANTIES AND COVENANTS

Each Debtor hereby covenants, represents and warrants that (all of such covenants, representations and warranties being continuing in nature until the Secured Obligations have been paid in full in cash or otherwise performed in full, and when no portion

of any Revolving Loan Commitment or Term Loan A Commitment remains outstanding and all outstanding Letters of Credit have been cash collateralized or otherwise terminated):

A. Subject to any exceptions or qualifications as set forth in Section 7.1.16 of the Loan Agreement, all of the existing Intellectual Property Collateral is valid and subsisting in full force and effect to such Debtor's knowledge, and such Debtor owns sole, full, and clear title thereto, and has the right and power to grant the security interests granted hereunder. Each Debtor will, at such Debtor's expense, perform all acts and execute all documents reasonably necessary to maintain the existence of the Intellectual Property Collateral as valid, subsisting and registered trademarks, patents and copyrights, including, without limitation, the filing of any renewal affidavits and applications. The Intellectual Property Collateral is not subject to any lien, security interest, claim or encumbrance ("Lien"), except the security interest granted hereunder, the licenses, if any, which are specifically described in Schedule C hereto and Permitted Liens.

B. Debtors will not assign, sell, mortgage, lease, transfer, pledge, hypothecate, grant a security interest in or Lien upon, encumber, grant an exclusive or non-exclusive license relating thereto (other than licenses in the ordinary course of business to customers of Debtors), except to Secured Party, or otherwise dispose of any of the Intellectual Property Collateral without the prior written consent of Secured Party except as permitted by the Loan Agreement.

C. Each Debtor will, at such Debtor's expense, perform all acts and execute all documents reasonably requested at any time by Secured Party to evidence, perfect, maintain, record, or enforce the security interest in the Intellectual Property Collateral granted hereunder or to otherwise further the provisions of this Agreement. Each Debtor hereby authorizes Secured Party to file one or more financing statements (or similar documents, including, without limitations, any filings needed to be filed with the United States Copyright Office (the "USCO")) with respect to the Intellectual Property Collateral. Each Debtor further authorizes Secured Party to have this or any other similar security agreement or amendment or supplement hereto filed with the Commissioner of Patents and Trademarks and USCO or other appropriate federal, state or government office and shall pay any associated filing fees.

D. Each Debtor will, concurrently with the execution and delivery of this Agreement, execute and deliver to Secured Party five originals of a Power of Attorney in the form of Exhibit 1 annexed hereto for the implementation of the assignment, sale or other disposition of the Intellectual Property Collateral pursuant to Secured Party's exercise of the rights and remedies granted to Secured Party hereunder. Secured Party agrees it will only exercise the Power of Attorney upon the occurrence and during the continuance of an Event of Default.

E. Secured Party may, in its sole discretion, pay any amount or do any act which any Debtor fails to pay or do as required hereunder or as requested by Secured Party to maintain and preserve the Intellectual Property Collateral, defend, protect, record, amend or enforce the Obligations, the Intellectual Property Collateral,

or the security interest granted hereunder including but not limited to, all filing or recording fees, court costs, collection charges and reasonable attorneys' fees. Debtors will be liable to Secured Party for any such payment, which payment shall be deemed a borrowing by Borrower from the Lenders, and shall be payable on demand together with interest at the rate set forth in the Loan Documents and shall be part of the Secured Obligations secured hereby.

F. As of the date hereof, Debtors do not have any Trademarks or Patents registered, or subject to pending applications, in the United States Patent and Trademark Office or any similar office or agency in the United States of America other than those described in Schedules A and B annexed hereto. As of the date hereof, Debtors do not have any Copyrights registered, or subject to pending applications, in the USCO or any similar office or agency in the United States of America other than those described in Schedule D annexed hereto

G. Each Debtor shall notify Secured Party in writing of the filing of any application by such Debtor for the registration of a Trademark, Patent or Copyright with the United States Patent and Trademark Office or USCO, as applicable, or any similar office or agency in the United States of America or any State therein within thirty days of such filing. Upon request of Secured Party, Debtors shall execute and deliver to Secured Party any and all amendments to this Agreement as may be requested by Secured Party to evidence the security interests of Secured Party in such Trademark, Patent or Copyright.

H. Debtors have not abandoned any of the Trademarks, Patents or Copyrights material to the conduct of its business and Debtors will not do any act, nor omit to do any act, whereby such Trademarks, Patents and Copyrights may become abandoned, canceled, invalidated, unenforceable, avoided, or avoidable. Each Debtor shall notify Secured Party immediately if such Debtor knows or has reason to know of any reason why any such application, registration, or recording may become abandoned, canceled, invalidated, unenforceable, avoided, or avoidable.

I. Each Debtor will take such actions in any proceeding before the United States Patent and Trademark Office, USCO, any federal or state court, or any similar office or agency in the United States of America or any State therein or any other country as are necessary to maintain such application and registration of the Trademarks, Patents and Copyrights material to the conduct of such Debtor's business as such Debtor's exclusive property and to protect Secured Party's interest therein, including, without limitation, filing of renewals, affidavits of use, affidavits of incontestability and opposition, interference, and cancellation proceedings.

J. Each Debtor will promptly notify Secured Party if such Debtor (or any affiliate or subsidiary thereof) learns of any use by any Person of any term or design likely to cause confusion with any Trademark or of any use by any Person of any other process or product which infringes upon any Patent, Trademark or Copyright. If requested by Secured Party, such Debtor, at such Debtor's expense, shall take such action as Secured Party, in Secured Party's reasonable discretion, may deem

advisable for the protection of Secured Party's interest in and to the Trademarks, Patents and Copyrights material to the conduct of such Debtor's business.

K. Each Debtor will maintain the quality of the products associated with the Trademarks at a level consistent with the quality at the time of this Agreement. Each Debtor hereby grants to Secured Party the right to visit such Debtor's plants and facilities which manufacture or store products sold under any of the Trademarks and to inspect the products and quality-control records relating thereto at such times as permitted in the Loan Agreement.

4. RIGHTS AND REMEDIES

Upon the occurrence of and during the continuance of an Event of Default, in addition to all other rights and remedies of Secured Party, whether provided under applicable law, the Loan Documents or otherwise, and after expiration of any grace period set forth in the Loan Documents or required under applicable law, Secured Party shall have the following rights and remedies which may be exercised without notice to, or consent by, Debtors, except as such notice or consent is expressly provided for hereunder or under the Loan Agreement and except as otherwise provided by applicable law.

A. Secured Party may make use of any Trademarks, Patents and Copyrights for the sale of goods or rendering of services in connection with enforcing any other security interest granted to Secured Party by Debtors or any Subsidiary of Debtors.

B. Secured Party may grant such license or licenses relating to the Intellectual Property Collateral for such term or terms, on such conditions, and in such manner as Secured Party shall in its sole discretion deem appropriate. Such license or licenses may be general, special, or otherwise and may be granted on an exclusive or non-exclusive basis throughout all or any part of the United States of America, its territories and possessions, and all foreign countries.

C. Secured Party may assign, sell, or otherwise dispose of the Intellectual Property Collateral or any part thereof, either with or without special conditions or stipulations, except that Secured Party agrees to provide Debtors with ten days prior written notice of any proposed disposition of the Intellectual Property Collateral. Secured Party shall have the power to buy the Intellectual Property Collateral or any part thereof, and Secured Party shall also have the power to execute assurances and perform all other acts which Secured Party may, in Secured Party's sole discretion, deem appropriate or proper to complete such assignment, sale or disposition. In any such event, Debtors shall be liable for any deficiency.

D. In addition to the foregoing, in order to implement the assignment, sale, or other disposition of any of the Intellectual Property Collateral pursuant to subparagraph 4C hereof, Secured Party may at any time execute and deliver on behalf of Debtors, pursuant to the authority granted in the Powers of Attorney described in subparagraph 3D hereof, one or more instruments of assignment

of the Trademarks, Patents and Copyrights (or any application, registration, or recording relating thereto), in form suitable for filing, recording or registration. Each Debtor agrees to pay Secured Party on demand all costs incurred in any such transfer of the Intellectual Property Collateral of such Debtor, including, but not limited to, any taxes, fees, and reasonable attorneys' fees.

E. Secured Party may apply the proceeds actually received from any such license, assignment, sale or other disposition of Intellectual Property Collateral first to the reasonable costs and expenses thereof, including, without limitation, reasonable attorneys' fees and all legal, travel, and other expenses which may be incurred by Secured Party. Thereafter, Secured Party may apply any remaining proceeds to the Secured Obligations in such order as provided in the Loan Agreement. Debtors shall remain liable to Secured Party and Lenders for any expenses or obligations remaining unpaid after the application of such proceeds, and Debtors will pay Secured Party on demand any such unpaid amount, together with interest at the default rate set forth in the Loan Agreement.

F. In the event that any such license, assignment, sale or disposition of the Intellectual Property Collateral (or any part thereof) is made after the occurrence and during the continuance of an Event of Default, each Debtor shall supply to Secured Party or Secured Party's designee such Debtor's knowledge and expertise relating to the manufacture and sale of the products and services bearing the Trademarks or to which the Patents and Copyrights relate and such Debtor's customer lists and other records relating to the Trademarks, Patents and Copyrights and the distribution thereof.

Nothing contained herein shall be construed as requiring Secured Party to take any such action at any time. All of Secured Party's rights and remedies, whether provided under law, this Agreement, the other Loan Documents, or otherwise, shall be cumulative and none is exclusive. Such rights and remedies may be enforced alternatively, successively, or concurrently.

5. MISCELLANEOUS

A. Any failure or delay by Secured Party to require strict performance by Debtors of any of the provisions, warranties, terms and conditions contained herein or in any other agreement, document, or instrument, shall not affect Secured Party's right to demand strict compliance and performance therewith, and any waiver of any Event of Default shall not waive or affect any other Event of Default, whether prior or subsequent thereto, and whether of the same or of a different type. None of the warranties, conditions, provisions, and terms contained herein or in any other agreement, document, or instrument shall be deemed to have been waived by any act or knowledge of Secured Party, its agents, officers, or employees, but only by an instrument in writing, signed by an officer of Secured Party and directed to Debtors, specifying such waiver.

B. All notices, requests and demands to or upon the respective parties hereto shall be made in accordance with Section 12.8 of the Loan Agreement. The Debtors hereby appoint Borrower as their authorized agent to receive any notices, requests or demands.

C. In the event any term or provision of this Agreement conflicts with any term or provision of the Loan Agreement, the term or provision of the Loan Agreement shall control.

D. In the event that any provision hereof shall be deemed to be invalid by any court, such invalidity shall not affect the remainder of this Agreement.

E. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective legal representatives, successors and assigns. No provision hereof shall be modified, altered or limited except by a written instrument expressly referring to this Agreement signed by the party to be charged thereby.

F. The security interest granted to Secured Party shall terminate when all Secured Obligations have been paid in full in cash or otherwise performed in full, and when no portion of any Revolving Loan Commitment or Term Loan A Commitment remains outstanding and all outstanding Letters of Credit have been cash collateralized or otherwise terminated.

G. Each Debtor hereby acknowledges and agrees that the waiver and consents, including without limitation any suretyship waivers, agreed to by the Aspen Pet Products, Inc. and Aspen Pet Products Holdings, Inc. in the Guaranty shall be applicable to this Agreement.





SECOND AMENDED AND RESTATED TRADEMARK, PATENT AND COPYRIGHT
SECURITY AGREEMENT
(Second Lien)

THIS SECOND AMENDED AND RESTATED TRADEMARK, PATENT AND COPYRIGHT SECURITY AGREEMENT (this "Agreement"), dated as of June 10, 2008, is entered into by and among each of the Persons listed on the signature pages hereto (each a "Debtor" and collectively "Debtors"), and BANK OF AMERICA, N.A. ("Bank of America"), in its capacity as Term Loan B ("Term Loan B Agent") for itself and the Secured Party (as defined below), having an office at 901 Main Street, 22nd Floor, TX1-492-22-13, Dallas, TX 75202, with reference to the following facts:

RECITALS

A. Dorskocil Manufacturing Company, Inc., a Texas corporation ("Borrower"), previously entered into the Amended and Restated Loan and Security Agreement dated as of January 31, 2006 (as heretofore amended, the "Original Loan Agreement"), among Borrower, the lenders party thereto, Bank of America, N.A., as agent and Ableco Finance LLC as term loan B agent, pursuant to which certain credit facilities were made available to Borrower.

B. In connection with the Original Loan Agreement, Aspen Pet Products Holdings, Inc. ("Aspen Holdings") and Aspen Pet Products, Inc. ("Aspen") entered into a Guaranty, dated January 31, 2006, in favor of Bank of America, as agent for the benefit of certain beneficiaries described therein (the "Original Guaranty").

C. In connection with the Original Loan Agreement, Borrower, Aspen Holdings and Aspen entered into an Amended and Restated Trademark and Patent Security Agreement dated January 31, 2006, in favor of Bank of America, as agent for the benefit of the secured party described therein (the "Original Trademark Security Agreement"). The Original Trademark Security Agreement secured, with respect to Aspen and Aspen Holdings, their obligations under the Original Guaranty, and with respect to Borrower its obligations under the Original Loan Agreement and other loan documents entered into in connection therewith.

D. The Original Loan Agreement is being amended and restated by the Second Amended and Restated Loan and Security Agreement of even date herewith, by and among Borrower, the lenders from time to time party thereto (each a "Lender" and collectively, the "Lenders"), Bank of America, N.A., as Agent, and Term Loan B Agent (as such agreement may from time to time be extended, modified, renewed, restated, supplemented or amended, the "Loan Agreement") pursuant to which the Lenders are making certain credit facilities available to Borrower.

E. In connection with the Loan Agreement, Aspen and Aspen Holdings have entered into an Amended and Restated Guaranty of even date herewith, in favor of Term Loan B Agent for the benefit of the beneficiaries described therein (as such agreement may from time to time be extended, modified, renewed, restated, supplemented or amended, the

"Guaranty") which amends and restates (but without novation) the Original Guaranty with respect to obligations owed to the beneficiaries described in the Guaranty.

F. The Loan Agreement provides, as a condition to the availability of the credit facilities described, that Debtors enter into this Agreement, which amends and restates (but without novation) the Original Trademark Security Agreement with respect to obligations owed to Secured Party and to grant security interests to Secured Party as herein provided.

G. The Original Trademark Security Agreement provided for the grant of two separate security interests for the benefit of certain separate sets of lenders. This Agreement is a continuation of the security interest granted thereunder for the benefit of Secured Party. Concurrently herewith Debtors are also entering into a Second Amended and Restated Trademark, Patent and Copyright Security Agreement for the benefit of Agent and the secured parties described therein, which amends and restates (but without novation) the Original Trademark Security Agreement with respect to obligations owed to such Persons.

H. Each Debtor expects to realize direct and indirect benefits as a result of the availability of the aforementioned credit facilities.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Debtors and Secured Party agree as follows:

1. DEFINITIONS. Terms defined in the Loan Agreement and not otherwise defined in this Agreement shall have the meanings given those terms in the Loan Agreement as though set forth herein in full. The following terms shall have the meanings respectively set forth after each:

"Agreement" means this Amended and Restated Trademark, Patent and Copyright Security Agreement, and any extensions, modifications, renewals, restatements, supplements or amendments hereof, including, without limitation, any documents or agreements by which additional Grantors become party hereto.

"Intellectual Property Collateral" means (a) all of Debtors' now existing or hereafter acquired right, title, and interest in and to: all of Debtors' trademarks, trade names, trade styles and service marks; all prints and labels on which such trademarks, trade names, trade styles and service marks appear, have appeared or will appear, and all designs and general intangibles of a like nature; all applications, registrations and recordings relating to the foregoing in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any State thereof, any political subdivision thereof or in any other countries, and all reissues, extensions and renewals thereof including, without limitation, those trademarks, terms, designs and applications described in Schedule A hereto (collectively, the "Trademarks"); (b) the goodwill of the business symbolized by each of the Trademarks, including, without limitation, all customer lists and other records relating to the distribution of products or services bearing the Trademarks; (c) all of Debtors' now existing or hereafter acquired right, title and interest in and to: all of Debtors' interests in any patents, whether foreign or domestic; all applications, registrations and recordings relating to such patents in the United States Patent and Trademark Office or in any similar office or agency of

the United States of America, any State thereof, any political subdivision thereof and all reissues, extensions and renewals thereof, including, without limitation, those patents, applications, registrations and recordings described in Schedule B hereto (the "Patents"); (d) all of Debtors' present and future copyrights, rights and interests in copyrights, works protectable by copyright, copyright registrations and copyright applications, whether foreign or domestic, and United States, state and international registrations of the foregoing, and all reissues, extensions and renewals of the foregoing, including, without limitation, those listed on Schedule D hereto (the "Copyrights"), together with all income, royalties, damages and payments now or hereafter due and/or payable with respect to the foregoing; the right to sue for past, present and future infringements of rights in copyrights, all goodwill of Grantors related thereto, and any and all proceeds of any of the foregoing, including, but not limited to, any and all proceeds of licensing thereof; and (e) any and all proceeds of any of the foregoing, including, without limitation, any claims by Debtors against third parties for infringement of the Trademarks, Patents, Copyrights or of any licenses with respect thereto.

"Secured Party" means collectively, Term Loan B Agent and the Term Loan B Lenders, and each of them, and any one or more of them, and their respective successors in interest. Subject to the terms of the Loan Agreement, any right, remedy, privilege or power of Secured Party shall be exercised by Term Loan B Agent.

"Secured Obligations" means, (a) as to Borrower, all Term Loan B Obligations of Borrower to Secured Party under the Loan Agreement and other Loan Documents, and (b) as to Aspen and Aspen Holdings, all Guaranteed Obligations (as defined in the Guaranty) of Aspen and Aspen Holdings to Secured Party under the Guaranty, including without limitation, as set forth in Section 2 of the Guaranty, all whether due or to become due, matured or unmatured, liquidated or unliquidated, or contingent or noncontingent, including obligations of performance as well as obligations of payment, and including interest that accrues after the commencement of any bankruptcy or insolvency proceeding by or against any Debtor.

2. SECURITY INTEREST

A. Security Interest in Intellectual Property Collateral. In order to secure the prompt and indefeasible payment and performance of the Secured Obligations, each Debtor hereby grants to Secured Party, a security interest in the Intellectual Property Collateral.

3. WARRANTIES AND COVENANTS

Each Debtor hereby covenants, represents and warrants that (all of such covenants, representations and warranties being continuing in nature until the Secured Obligations have been paid in full in cash or otherwise performed in full, and when no portion of the Term Loan B Commitment remains outstanding):

A. Subject to any exceptions or qualifications as set forth in Section 7.1.16 of the Loan Agreement, all of the existing Intellectual Property Collateral is valid and subsisting in full force and effect to such Debtor's knowledge, and such Debtor owns sole, full, and clear title thereto, and has the right and power to

grant the security interests granted hereunder. Each Debtor will, at such Debtor's expense, perform all acts and execute all documents reasonably necessary to maintain the existence of the Intellectual Property Collateral as valid, subsisting and registered trademarks, patents and copyrights, including, without limitation, the filing of any renewal affidavits and applications. The Intellectual Property Collateral is not subject to any lien, security interest, claim or encumbrance ("Lien"), except the security interest granted hereunder, the licenses, if any, which are specifically described in Schedule C hereto and Permitted Liens.

B. Debtors will not assign, sell, mortgage, lease, transfer, pledge, hypothecate, grant a security interest in or Lien upon, encumber, grant an exclusive or non-exclusive license relating thereto (other than licenses in the ordinary course of business to customers of Debtors), except to Secured Party, or otherwise dispose of any of the Intellectual Property Collateral without the prior written consent of Secured Party except as permitted by the Loan Agreement.

C. Each Debtor will, at such Debtor's expense, perform all acts and execute all documents reasonably requested at any time by Secured Party to evidence, perfect, maintain, record, or enforce the security interest in the Intellectual Property Collateral granted hereunder or to otherwise further the provisions of this Agreement. Each Debtor hereby authorizes Secured Party to file one or more financing statements (or similar documents, including, without limitations, any filings needed to be filed with the United States Copyright Office (the "USCO")) with respect to the Intellectual Property Collateral. Each Debtor further authorizes Secured Party to have this or any other similar security agreement or amendment or supplement hereto filed with the Commissioner of Patents and Trademarks and USCO or other appropriate federal, state or government office and shall pay any associated filing fees.

D. Each Debtor will, concurrently with the execution and delivery of this Agreement, execute and deliver to Secured Party five originals of a Power of Attorney in the form of Exhibit 1 annexed hereto for the implementation of the assignment, sale or other disposition of the Intellectual Property Collateral pursuant to Secured Party's exercise of the rights and remedies granted to Secured Party hereunder. Secured Party agrees it will only exercise the Power of Attorney upon the occurrence and during the continuance of an Event of Default.

E. Secured Party may, in its sole discretion, pay any amount or do any act which any Debtor fails to pay or do as required hereunder or as requested by Secured Party to maintain and preserve the Intellectual Property Collateral, defend, protect, record, amend or enforce the Obligations, the Intellectual Property Collateral, or the security interest granted hereunder including but not limited to, all filing or recording fees, court costs, collection charges and reasonable attorneys' fees. Debtors will be liable to Secured Party for any such payment, which payment shall be deemed a borrowing by Borrower from the Lenders, and shall be payable on demand together with interest at the rate set forth in the Loan Documents and shall be part of the Secured Obligations secured hereby.

F. As of the date hereof, Debtors do not have any Trademarks or Patents registered, or subject to pending applications, in the United States Patent and Trademark Office or any similar office or agency in the United States of America other than those described in Schedules A and B annexed hereto. As of the date hereof, Debtors do not have any Copyrights registered, or subject to pending applications, in the USCO or any similar office or agency in the United States of America other than those described in Schedule D annexed hereto

G. Each Debtor shall notify Secured Party in writing of the filing of any application by such Debtor for the registration of a Trademark, Patent or Copyright with the United States Patent and Trademark Office, USCO, as applicable, or any similar office or agency in the United States of America or any State therein within thirty days of such filing. Upon request of Secured Party, Debtors shall execute and deliver to Secured Party any and all amendments to this Agreement as may be requested by Secured Party to evidence the security interests of Secured Party in such Trademark, Patent or Copyright.

H. Debtors have not abandoned any of the Trademarks, Patents or Copyrights material to the conduct of its business and Debtors will not do any act, nor omit to do any act, whereby such Trademarks, Patents and Copyrights may become abandoned, canceled, invalidated, unenforceable, avoided, or avoidable. Each Debtor shall notify Secured Party immediately if such Debtor knows or has reason to know of any reason why any such application, registration, or recording may become abandoned, canceled, invalidated, unenforceable, avoided, or avoidable.

I. Each Debtor will take such actions in any proceeding before the United States Patent and Trademark Office, USCO, any federal or state court, or any similar office or agency in the United States of America or any State therein or any other country as are necessary to maintain such application and registration of the Trademarks, Patents and Copyrights material to the conduct of such Debtor's business as such Debtor's exclusive property and to protect Secured Party's interest therein, including, without limitation, filing of renewals, affidavits of use, affidavits of incontestability and opposition, interference, and cancellation proceedings.

J. Each Debtor will promptly notify Secured Party if such Debtor (or any affiliate or subsidiary thereof) learns of any use by any Person of any term or design likely to cause confusion with any Trademark or of any use by any Person of any other process or product which infringes upon any Patent, Trademark or Copyright. If requested by Secured Party, such Debtor, at such Debtor's expense, shall take such action as Secured Party, in Secured Party's reasonable discretion, may deem advisable for the protection of Secured Party's interest in and to the Trademarks, Patents and Copyrights material to the conduct of such Debtor's business.

K. Each Debtor will maintain the quality of the products associated with the Trademarks at a level consistent with the quality at the time of this Agreement. Each Debtor hereby grants to Secured Party the right to visit such Debtor's plants and facilities which manufacture or store products sold under any of

the Trademarks and to inspect the products and quality-control records relating thereto at such times as permitted in the Loan Agreement.

4. RIGHTS AND REMEDIES

Upon the occurrence of and during the continuance of an Event of Default, in addition to all other rights and remedies of Secured Party, whether provided under applicable law, the Loan Documents or otherwise, and after expiration of any grace period set forth in the Loan Documents or required under applicable law, Secured Party shall have the following rights and remedies which may be exercised without notice to, or consent by, Debtors, except as such notice or consent is expressly provided for hereunder or under the Loan Agreement and except as otherwise provided by applicable law.

A. Secured Party may make use of any Trademarks, Patents and Copyrights for the sale of goods or rendering of services in connection with enforcing any other security interest granted to Secured Party by Debtors or any Subsidiary of Debtors.

B. Secured Party may grant such license or licenses relating to the Intellectual Property Collateral for such term or terms, on such conditions, and in such manner as Secured Party shall in its sole discretion deem appropriate. Such license or licenses may be general, special, or otherwise and may be granted on an exclusive or non-exclusive basis throughout all or any part of the United States of America, its territories and possessions, and all foreign countries.

C. Secured Party may assign, sell, or otherwise dispose of the Intellectual Property Collateral or any part thereof, either with or without special conditions or stipulations, except that Secured Party agrees to provide Debtors with ten days prior written notice of any proposed disposition of the Intellectual Property Collateral. Secured Party shall have the power to buy the Intellectual Property Collateral or any part thereof, and Secured Party shall also have the power to execute assurances and perform all other acts which Secured Party may, in Secured Party's sole discretion, deem appropriate or proper to complete such assignment, sale or disposition. In any such event, Debtors shall be liable for any deficiency.

D. In addition to the foregoing, in order to implement the assignment, sale, or other disposition of any of the Intellectual Property Collateral pursuant to subparagraph 4C hereof, Secured Party may at any time execute and deliver on behalf of Debtors, pursuant to the authority granted in the Powers of Attorney described in subparagraph 3D hereof, one or more instruments of assignment of the Trademarks, Patents and Copyrights (or any application, registration, or recording relating thereto), in form suitable for filing, recording or registration. Each Debtor agrees to pay Secured Party on demand all costs incurred in any such transfer of the Intellectual Property Collateral of such Debtor, including, but not limited to, any taxes, fees, and reasonable attorneys' fees.

E. Secured Party may apply the proceeds actually received from any such license, assignment, sale or other disposition of Intellectual Property Collateral first to the reasonable costs and expenses thereof, including, without limitation, reasonable attorneys' fees and all legal, travel, and other expenses which may be incurred by Secured Party. Thereafter, Secured Party may apply any remaining proceeds to the Secured Obligations in such order as provided in the Loan Agreement. Debtors shall remain liable to Secured Party and Lenders for any expenses or obligations remaining unpaid after the application of such proceeds, and Debtors will pay Secured Party on demand any such unpaid amount, together with interest at the default rate set forth in the Loan Agreement.

F. In the event that any such license, assignment, sale or disposition of the Intellectual Property Collateral (or any part thereof) is made after the occurrence and during the continuance of an Event of Default, each Debtor shall supply to Secured Party or Secured Party's designee such Debtor's knowledge and expertise relating to the manufacture and sale of the products and services bearing the Trademarks or to which the Patents and Copyrights relate and such Debtor's customer lists and other records relating to the Trademarks, Patents and Copyrights and the distribution thereof.

Nothing contained herein shall be construed as requiring Secured Party to take any such action at any time. All of Secured Party's rights and remedies, whether provided under law, this Agreement, the other Loan Documents, or otherwise, shall be cumulative and none is exclusive. Such rights and remedies may be enforced alternatively, successively, or concurrently.

5. MISCELLANEOUS

A. Any failure or delay by Secured Party to require strict performance by Debtors of any of the provisions, warranties, terms and conditions contained herein or in any other agreement, document, or instrument, shall not affect Secured Party's right to demand strict compliance and performance therewith, and any waiver of any Event of Default shall not waive or affect any other Event of Default, whether prior or subsequent thereto, and whether of the same or of a different type. None of the warranties, conditions, provisions, and terms contained herein or in any other agreement, document, or instrument shall be deemed to have been waived by any act or knowledge of Secured Party, its agents, officers, or employees, but only by an instrument in writing, signed by an officer of Secured Party and directed to Debtors, specifying such waiver.

B. All notices, requests and demands to or upon the respective parties hereto shall be made in accordance with Section 12.8 of the Loan Agreement. The Debtors hereby appoint Borrower as their authorized agent to receive any notices, requests or demands.

C. In the event any term or provision of this Agreement conflicts with any term or provision of the Loan Agreement, the term or provision of the Loan Agreement shall control.

D. In the event that any provision hereof shall be deemed to be invalid by any court, such invalidity shall not affect the remainder of this Agreement.

E. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective legal representatives, successors and assigns. No provision hereof shall be modified, altered or limited except by a written instrument expressly referring to this Agreement signed by the party to be charged thereby.

F. The security interest granted to Secured Party shall terminate when all Secured Obligations have been paid in full in cash or otherwise performed in full, and when no portion of the Term Loan B Commitment remains outstanding.

G. Each Debtor hereby acknowledges and agrees that the waiver and consents, including without limitation any suretyship waivers, agreed to by the Aspen Pet Products, Inc. and Aspen Pet Products Holdings, Inc. in the Guaranty shall be applicable to this Agreement.






