NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of June 23, 2008 by CapitalSource Finance, LLC, as Lender for its own benefit as such capitalized terms are defined in the Credit Agreement (defined below) (in such capacity, the "Assignee") for the benefit of RCR Plumbing and Mechanical, Inc., a California corporation f/k/a RCR Plumbing, Inc. (the "Assignor").

WHEREAS, the Assignor granted to the Assignee a security interest in all of the Assignor's right, title and interest in and to the trademarks (i) RCR COMPANIES, Registration Number 2582115, and (ii) RCR, Registration Number 3,208,921, together with all goodwill of the business connected with the use of, and symbolized by, each such Trademark, and the proceeds thereof (collectively, the "Trademark Collateral"), pursuant to and under that (a) Revolving Credit, Term Loan and Security Agreement dated as of November 30, 2005 (as amended or otherwise modified from time to time, the "Credit Agreement") between the Assignor and RCR Mechanical, Inc., as co-borrowers, and the Assignee, (b) Intellectual Property Security Agreement dated as of November 30, 2005 between the Assignor and the Assignee and having been recorded with the U.S. Patent and Trademark Office on December 15, 2005 at Reel Number 003210 and Frame Number 0979, and (c) First Amendment to Intellectual Property Security Agreement dated as of April 9, 2008 between the Assignor and the Assignee and having been recorded with the U.S. Patent and Trademark Office on May 9, 2008 at Reel Number 3775 and Frame Number 0586 (the "Grant of Security Interest in Trademarks"), and

WHEREAS, the Assignor having paid in full the Obligations, as such term is defined in the Credit Agreement and used in the Grant of Security Interest in Trademarks, for which the Trademark Collateral was collateral security.

NOW THEREFORE, the Assignee does hereby give notice and confirm that has relinquished, released and discharged its security interest in the Trademark Collateral and the Grant of Security Interest in Trademarks is hereby deemed terminated.
