TERMINATION AND RELEASE OF SECURITY INTEREST

1. This Termination and Release is made and effective as of May 12, 1998, pursuant to an Order Authorizing Sale of Properties of the Estates Pursuant to Section 363 of the Bankruptcy Code Free and Clear of Liens and Claims dated May 11, 1998 ("Sale Order") by the United States Bankruptcy Court for the Eastern District of Wisconsin in the jointly administered Chapter 11 cases entitled In re AR Accessories Group, Inc., Case No. 98-22580-JES and In re The Wallet Works, Inc., Case No. 98-22750-JES.


2. Under the Trademark Collateral Security and Pledge Agreement, recorded November 13, 1995, in the U.S. Patent and Trademark Office, Bank One, Wisconsin had a security interest in registered trademark number 1,345,221 and in registered trademark number 1,389,016 (together the "Marks"). The Marks were owned by AR Accessories Group, Inc.

3. Pursuant to the Sale Order, AR Accessories Group, Inc. transferred, assigned, and sold all of the right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks to Rosedale Wilsons, Inc.

4. Bank One, Wisconsin hereby terminates the Trademark Collateral Security and Pledge Agreement and releases its security interest in the Marks.

IN WITNESS WHEREOF, Bank One, Wisconsin has caused this Termination and Release to be duly executed as of May 12, 1998.
