
ASSIGNMENT OF MARKS

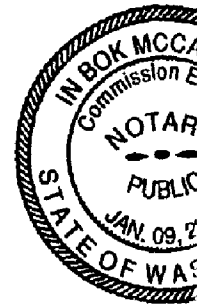



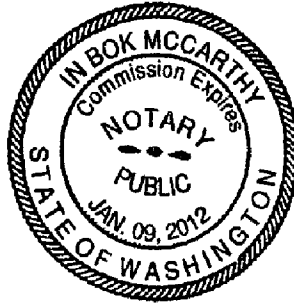
