**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, Citicorp USA, Inc., as Administrative Agent (“Secured Party”), recorded a security interest (in its capacity as administrative agent) in, *inter alia*, six trademark registrations identified on Schedule A annexed hereto, together with the goodwill of the business symbolized thereby (the “Swarm Marks”), which are owned by one or more of Minnesota Hockey Ventures Group, LP; Minnesota Wild Hockey Club, LP; Saint Paul Facilities Management, LLC; Saint Paul Arena Company, LLC; MHVG Cuisine, LLC; Wildside Caterers, LLC; NS Holdings, LLC; MSE Holdings, LP; Aeros Hockey Club, LLC; 317 Washington, LLC; Minnesota Outdoor Entertainment, LLC; Rose Wild, LLC; Minnesota Wild Gear, LLC; MXL Acquisition, LP; and MXL GP, LLC (collectively, “Debtors”), pursuant to that certain Notice of Security Interest in Intellectual Property – Trademarks dated April 11, 2008, recorded in the United States Patent and Trademark Office at Reel/Frame No. 3452/0267 (the “Security Agreement”);

WHEREAS, the recordation of security interest in the Swarm Marks under the Security Agreement was made in error, and the Secured Party wishes to release any and all security interests that the Secured Party actually or purportedly holds in the Swarm Marks; and

WHEREAS, this Release of Security Interest in Trademarks is intended to release the Secured Party’s actual or purported security interests in the Swarm Marks only, without prejudice to or release of any other security interests in any other assets of the Debtors, including without limitation any other trademarks, service marks, registrations or applications for registration thereof, or goodwill symbolized thereby, that were granted under the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party’s security interests in the Swarm Marks are released and all interests in the Swarm Marks that were previously assigned to the Secured Party under the Security Agreement are hereby reassigned to Debtors, without representation or warranty of any kind, nature or description.
