Now on this <sup>17</sup>/<sub>16</sub> day of June, 2008, ADP, INC. and ADP OF NORTH AMERICA, INC. both Delaware corporations, pursuant to Section 251 of the General Corporation Law of the State of Delaware, have entered into the following Agreement of Merger.

WITNESSETH that:

WHEREAS, the respective Boards of Directors of the foregoing named corporations deem it advisable that the corporations merge into a single corporation as hereinafter specified; and

WHEREAS, said ADP, INC. filed its Certificate of Incorporation in the office of the Secretary of State of the State of Delaware on August 13, 1970; and

WHEREAS, said ADP OF NORTH AMERICA, INC. filed its Certificate of Incorporation in the office of the Secretary of State of the State of Delaware on January 28, 1988;

NOW, THEREFORE, the corporations, parties to this Agreement, by and between their respective Boards of Directors, in consideration of the mutual covenants, agreements and provisions hereinafter contained, do hereby prescribe the terms and conditions of said merger and of carrying the same into effect as follows:

FIRST: The ADP OF NORTH AMERICA, INC. hereby is merged into ADP, INC. which shall be the surviving corporation.

SECOND: The Certificate of Incorporation of ADP, INC., as in effect on the date of the merger provided for in this Agreement, shall continue in full force and effect as the Certificate of Incorporation of the corporation surviving the merger.


