EXHIBIT D

OMNIBUS TRADEMARK ASSIGNMENT

This Assignment Agreement is entered into the 17th day of June 2008, by and between Fantasy Sports Network Inc., an Ontario corporation with a registered office at 33 Carlingview Drive, Toronto, Canada M9W 5E4 ("Assignor"), and Twentieth Century Fox Film Corporation, a Delaware corporation with its principal place of business at 10201 West Pico Boulevard Los Angeles, CA 90035 ("Assignee")

WHEREAS:

(A) The Assignor is the legal and beneficial owner of the trademarks FSN and of the trademark registrations listed in Schedule "A" to this Assignment Agreement and related rights as defined herein (hereinafter the "Assigned Trademarks") and intends, subject to the terms and conditions of this Assignment Agreement, to assign the legal and beneficial ownership in the Assigned Trademarks and some of the related rights thereto, to the Assignee with full title guarantee; and

(B) The Assignee wishes to purchase from Assignor all rights in and title to the Assigned Trademarks, together with the goodwill associated with the Assigned Trademarks.

IT IS HEREBY AGREED as follows:

ASSIGNMENT

1.1 For valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby sells, assigns, transfers and conveys with full title guarantee to the Assignee, its successors and assigns:

(a) Assignor's right, title and interest in and to the Assigned Trademarks in the United States listed in Schedule A; and,

(b) Any and all goodwill, common law rights and other rights arising under applicable law related to the Assigned Trademarks.

(c) The right to recover damages and/or profits arising from past infringement of the Assigned Trademark and the right to sue for and receive same in Assignee's name.

1.2 The Assignor hereby agrees to execute specific confirmatory assignment and other supplementary documents (as may be required) in favor of the Assignee in order to facilitate the Assignee's recordal, at the Assignee's expense, of the assignment of the Assigned Trademarks at the U.S. Patent & Trademark Office.

1.3 The Assignor, at the reasonable request of Assignee, further agrees to co-operate and assist the Assignee in any legal requirements relating to the status, validity or enforceability of the Assigned Trademarks, including providing Assignee with any information regarding use of the Assigned Trademarks by Assignor, its affiliates and/or licensees in connection with the prior manufacture, promotion, sale and advertising of any products bearing the Assigned Trademarks.

1.4 The rights and obligations stated in and/or arising from this Assignment Agreement shall extend to and be binding upon all successors, licensees and assigns of the parties hereto.
