Pursuant to RCW 23B.10.020 and RCW 23B.10.060 of the Washington Business Corporation Act, the undersigned corporation hereby submits the following amendment to the corporation's Amended and Restated Articles of Incorporation.

1. The name of the corporation is WestCoast Hotels, Inc.
2. The text of the amendment to Article I, Name, as adopted, is as follows:
"The name of this corporation is Red Lion Hotels Franchising, Inc."
3. The date of adoption of such amendment was September 14, 2005.
4. Pursuant to RCW 23B.10.020, the amendment was adopted by the Board of Directors. The restatement does not include an amendment requiring shareholder approval, therefore shareholder action was not required.
