TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT, effective as of the 30<sup>th</sup> day of June, 2008, from FAMIS MANUFACTURING, INC., a Wisconsin corporation ("Assignor"), to LITTLE RAPIDS CORPORATION, a Wisconsin corporation ("Assignee").

WHEREAS, Assignee is acquiring substantially all of the assets of Assignor pursuant to that certain Asset Purchase Agreement dated as of June 23, 2008, by and among Assignor, Assignee, Beth Aschenbrenner, Ralph Aschenbrenner and James J. Schmitt (the "Purchase Agreement"); and

WHEREAS, in connection with the Purchase Agreement, Assignee is acquiring all of Assignor's right, title and interest, throughout the world, in and to the trademarks listed on Schedule A attached hereto (the "Trademarks"), and any applications and registrations therefor, together with the goodwill of the business in connection with which the Trademarks are used and which is symbolized by the Trademarks, along with the right to recover damages and profits for past and future infringements thereof.

NOW, THEREFORE, for the good and valuable consideration set forth in the Purchase Agreement, the sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, and transfer unto Assignee all of Assignor's right, title, and interest in and to the Trademarks, and any applications or registrations therefor, together with all common law rights therein, the goodwill of the business in connection with which the Trademarks are used and which is symbolized by the Trademarks, throughout the world, all renewals thereof, and all rights of action, powers, and benefits accrued thereto, including the right to sue for and collect damages and profits for past and future infringements thereof.

Assignor agrees to execute and deliver, at the request of Assignee, all papers, instruments, and assignments, and to perform any other acts reasonably deemed necessary by Assignee in order to vest all right, title, and interest in and to the Trademarks to Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate such assignment.
