NOTICE OF TRADEMARK SECURITY AGREEMENT
(FOR RECORDATION PURPOSES)

This Notice of Trademark Security Agreement, dated as of June 20, 2008, is made with regard to BRONER GLOVE COMPANY, a Michigan corporation, whose address and principal place of business is 1750 Harmon Road, Auburn Hills, Michigan 48326 (the "Debtor"), by FIRST BUSINESS CAPITAL CORP., a Wisconsin corporation, whose address and principal place of business is 401 Charmany Drive, Madison, Wisconsin 53719 (the "Secured Party").

RECITALS:
