RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") dated April 1st, 2008 is made by TelAmerica Media Incorporated, a Delaware corporation, hereinafter generally referred to as "TelAmerica", ("the Secured Party") party to a security agreement ("the Security Agreement") with Ray Cook Golf Company 2233 Faraday Avenue, Carlsbad, CA 92008 ("the Debtor");

WITNESSETH:
