AFFIDAVIT


I, Nicholas E. Evans-Lombe, Executive Vice President of Getty Images, Inc., a Delaware corporation, with a principal place of business at 601 North 34th Street, Seattle, Washington 98103, have personal knowledge of the following matters:

1. Getty Images, Inc. filed a trademark application for the mark ENERGY FILM on December 22, 1999. This application was assigned Serial Number 75/879,926 which matured into Registration Number 2,607,944 on August 13, 2002.
2. In the course of due diligence and in preparation for filing a Section 8 & 15 Declaration for the ENERGY FILM mark, we learned that application Serial Number 75/879,926 had been erroneously assigned due to a typographical error to Planalytics, Inc. by Strategic Weather Services, Inc.
3. The erroneous assignment was recorded at the USPTO beginning at Reel 002088/Frame 0946. The typographical error in the serial numbers occurs at Frame 0949 of the recorded assignment.
4. Upon further investigation of the other marks owned by Strategic Weather Services, Inc. and assigned to Planalytics, Inc., it was determined that the assignment should have included Serial Number 75/897,926 for the mark VERTICALPLAN.
5. Neither Planalytics, Inc. nor Strategic Weather Services, Inc. are in any way related to Getty Images, Inc. which is the true owner of the ENERGY FILM trademark registration. Getty Images, Inc. has never assigned the ownership of the ENERGY FILM application or the resulting registration to any entity.
6. The original, correct registrant for the mark ENERGY FILM, U.S. Registration Number 2,607,944, has been and continues to be Getty Images, Inc.

Based on the above information, the USPTO Assignment Division's records should be amended to show Getty Images, Inc. as the correct owner of the ENERGY FILM trademark registration.

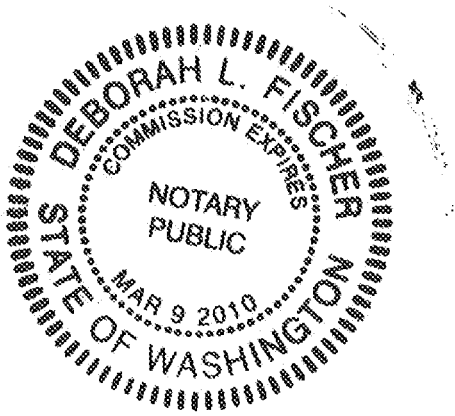
