IP ASSIGNMENT AGREEMENT

THIS IP ASSIGNMENT AGREEMENT (this "Agreement") is made and entered into effective as of March 25 2008 ("Effective Date") by and between:

Medtronic Spine LLC (formerly known as Kyphon Inc.), a Delaware limited liability company, with its principal place of business located at 1221 Crossman Ave, Sunnyvale, CA 94089 ("Medtronic LLC"), and

Kyphon SÀRL, a limited liability company organized and existing under the laws of Switzerland, with its registered address at rue du Puits-Godet 12/12a, 2000 Neuchâtel, Switzerland ("Kyphon Sarl").

RECITALS

- A. Medtronic and its affiliates including, without limitation, Medtronic LLC and Kyphon Sarl, are in the process of integrating the Medtronic and Kyphon businesses.
- B. As part of the integration, Medtronic LLC desires to transfer and assign to Kyphon Sarl all of Medtronic LLC's right, title and interest in and to the IP Assets (as defined herein), as a contribution to the capital of Kyphon Sarl (the "IP Assignment").
- C. This Agreement is intended to effect the IP Assignment with an effective time as of close of business on January 22, 2008 (the "Effective Time").

NOW, THEREFORE, in consideration of the foregoing, the parties hereby agree as follows:

SECTION 1 ASSIGNMENT OF IP ASSETS

1.1 Assignment of Intellectual Property. Subject to the terms and conditions of this Agreement, as of the Effective Time, Medtronic LLC hereby assigns, transfers, conveys and delivers to Kyphon Sarl and Kyphon Sarl hereby acquires and accepts:

(a) Patents and Copyrights. All of its rights, title, and interest in and to the following: (i) all inventions, patents, and pending applications including, without limitation, those listed in Schedule 1; and (ii) all copyrights, registered and unregistered, including, without limitation, those listed in Schedule 2; that relate to Medtronic LLC's business operations, products, and services (collectively the "Intellectual Property"), together with (iii) all the rights and privileges that inhere in such Intellectual Property including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement thereof;

(b) Trademarks. All of its rights, title, and interest in and to all trademarks, service marks, trade dresses, logos, designs and slogans, whether in word mark, stylized or design format, registered and unregistered including, without limitation, those listed in Schedule 3 (the "Marks"), together with the goodwill of Medtronic LLC's business connected with the use of and symbolized by the Marks and all the rights and privileges that inhere in such Marks including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement thereof; and

(c) Licenses. All of its rights and obligations under those certain licenses listed in Schedule 4 (the "Licenses"). (The Intellectual Property, the Marks and the rights under the Licenses are collectively referred to in this Agreement as the "IP Assets.")

1.2 Deliveries. Medtronic LLC will deliver to Kyphon Sarl such documents as are necessary to transfer the IP Assets listed in Section 1.1 above.

1.3 Acknowledgment. Medtronic LLC acknowledges that, from and after the Effective Time, Kyphon Sarl is the owner of all rights, title and interest in and to the Intellectual Property and Marks in any form or embodiment thereof and is also the owner of the goodwill attached to the Marks. Medtronic LLC will not at any time do or suffer to be done any act or thing that may materially adversely affect any rights of Kyphon Sarl in or to the Intellectual Property and Marks. Kyphon Sarl acknowledges that Medtronic LLC has granted certain licenses to the Intellectual Property and Marks and that Kyphon Sarl acquires such Intellectual Property and Marks subject to such licenses and other rights.

1.4 Cooperation. Medtronic LLC will take all actions necessary to execute any and all documents as may be reasonably requested by Kyphon Sarl from time to time to fully vest or perfect in Kyphon Sarl all right, title and interest in and to the IP Assets pursuant to this Agreement. Such actions may include without limitation, providing documents and information useful or necessary for the prosecution of any application to register or perfect any of the IP Assets, maintaining any trademark registration, or pursuing or defending any administrative, court or other legal proceeding involving one or more of the IP Assets.

SECTION 2 MISCELLANEOUS PROVISIONS

2.1 Further Assurances. The parties hereto shall each perform such acts, execute and deliver such instruments and documents, and do all such other things as may be reasonably necessary to effect the assignment of the IP Assets as contemplated in this Agreement. The parties acknowledge and agree that certain of the assignments contemplated by this Agreement may not be effected as of the Effective Time due to the inability of the parties to obtain necessary consents or approvals or the inability of the parties to take certain other actions necessary to effect such assignments. To the extent any assignments contemplated by this Agreement have not been fully effected as of Effective Time, Medtronic LLC and Kyphon Sarl shall cooperate and use commercially reasonable efforts to obtain any necessary consents or approvals or take any other actions necessary to effect such transfers as promptly as practicable following the Effective Time. Nothing herein shall effect the assignment of any asset to the extent that such assignment causes forfeiture or loss of such asset. If an attempted assignment would be ineffective or would impair Kyphon Sarl's rights under any such asset so that Kyphon Sarl would not receive all such rights, then the parties will use commercially reasonable efforts to provide to, or cause to be provided to, Kyphon Sarl, to the extent permitted by law, the rights of any such asset and take such other actions as may reasonably be requested by Kyphon Sarl in order to place Kyphon Sarl, insofar as reasonably possible, in the same position as if such asset had been transferred as contemplated hereby.

2.2 Governing Law. The internal laws of the State of California (without reference to its principles of conflicts of law) govern the construction, interpretation and other matters arising out of or in connection with this Agreement (whether arising in contract, tort, equity or otherwise).

2.3 Severability. If any provision of this Agreement is determined to be invalid, illegal or unenforceable, the remaining provisions of this Agreement remain in full force, if the essential terms and conditions of this Agreement for each party remain valid, binding and enforceable.

2.4 Amendment. No change, modification or amendment of this Agreement shall be valid or binding on the parties unless such change or modification shall be in writing signed by the party against whom the same is sought to be enforced.

2.5 Counterparts. The parties may execute this Agreement in counterparts, each of which constitutes an original as against the party that signed it, and all of which together constitute one agreement. The signatures of both parties need not appear on the same counterpart. The delivery of signed counterparts by facsimile or email transmission that includes a copy of the sending party's signature is as effective as signing and delivering the counterpart in person.
