NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:



Assignor further agrees to cause to be performed such other lawful acts and to be executed such confirmatory assignments and other legal documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of each of the rights hereby conveyed.
