TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT ("*Assignment*") made as of July 7, 2008, by and between DEL PHARMACEUTICALS, INC., a Delaware corporation ("*Seller*"), and CHURCH & DWIGHT CO., INC., a Delaware corporation (the "*Purchaser*").

WHEREAS, Seller and the Purchaser have entered into an Asset Purchase Agreement, dated as of March 28, 2008 (the "*Asset Purchase Agreement*"), pursuant to which, among other things, Seller has agreed to, and to cause the other Sellers to, sell, assign, transfer, convey and deliver to the Purchaser the trademark applications and registrations identified in Schedule A hereto (collectively, "*Trademarks*"). Capitalized terms used but not defined in this Assignment shall have the meanings assigned to them in the Asset Purchase Agreement.

NOW, THEREFORE, in consideration of the sum of One Dollar and the mutual covenants and obligations set forth herein and in the Asset Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Seller does hereby sell, assign, transfer, convey and deliver unto the Purchaser the entire right, title and interest in and to the Trademarks, to be held and enjoyed by Purchaser as fully and entirely as it would have been held and enjoyed by Seller if this assignment had not been made, including all claims, demands and rights of recovery that Seller has or may have in profits and damages for past (except, with respect to any Excluded Liability, as limited by Section 1.2(a)(xv) of the Asset Purchase Agreement) and future infringements of the Trademarks, if any, and all rights to compromise, sue for, and collect such profits and damages, together with all goodwill and the portion of the Acquired Assets associated therewith.


