JOHN M. FOSTER and JOSEPH P. FOSTER certify that:


- 1. They are the President and Secretary, respectively, of John M. Foster Turf Farms, Inc. a California corporation.
- 2. Article ONE of the Articles of Incorporation of this corporation is amended to read as follows:


"ONE: The name of this corporation is West Coast Turf."

- 3. The foregoing amendment of Articles of Incorporation has been duly approved by the Board of Directors.
- 4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the corporations code. The total number of outstanding voting shares of the corporation is 192,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%).
