INTELLECTUAL PROPERTY ASSIGNMENT

In consideration of the covenants, representations and warranties by and between the Parties, as well as other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby: (a) sells, assigns, transfers and conveys to Manzen Assignor's entire right, title, and interest in and to all of Assignor's intellectual property (the "Assigned Intellectual Property"), including, without limitation, (i) all foreign, federal, state and common law patents, inventions (whether or not patentable), copyrights, trademarks, service marks, trade dress, trade names, domain names, trade secrets, proprietary data and other intangible assets of whatsoever nature and all goodwill, applications for registration, registrations and/or issuances with respect to the foregoing (including, without limitation, the U.S. federal trademark and service mark registrations and applications listed in **Schedule 1**) and (ii) the right to sue and recover for any past and/or continuing infringements, violations, dilutions, misappropriations or contract breaches, said rights, titles and interests to be held and enjoyed by Manzen, for Manzen's own use and benefit and for the use and benefit of Manzen's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment, transfer and conveyance had not been made; (b) covenants, represents and warrants that: (i) immediately prior to the execution of this Assignment, Assignor had all right, title and interest (including, without limitation, all intellectual property right, title and interest) in and to the Assigned Intellectual Property and (ii) no person or entity (other than Manzen) has any right, title, or interest in and to the Assigned Intellectual Property, including, without limitation, by way of encumbrance, lien, or any other method or means; and (c) waives and releases any claim of infringement of any right, title, or interest of Assignor (whether based in any intellectual property right, other proprietary interest whatsoever or applicable fiduciary theory) in, to or respecting the Assigned Intellectual Property and shall never challenge nor dispute Manzen's right, title, and interest in and to the Assigned Intellectual Property.
