

Law ' 1005 hereby, nunc pro tunc and effective as of June 26, 2002, sells, assigns and transfers unto the Assignee, its successors and assigns, the entire right, title and interest in and to the said mark and the Registration and any renewals that may be granted thereon, together with the goodwill of the business symbolized by the mark and all rights to damages or profits, due or to become due, accrued or to become due, accrued or to accrue, arising out of past, present or future infringement of said mark or injury to said goodwill, together with the right to sue or recover the same.

The undersigned declares on behalf of the Assignor, that she is properly authorized to make this declaration; that the Assignor owned the entire right, title and interest in the trademark BEN KAHN; that the Assignor did not transfer or otherwise assign any interest or partial interest in the trademark at any time, other than to the Assignee; and that any willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements may jeopardize the validity of the Registration and declares that the facts set forth in this Declaration are true; all statements made of her own knowledge are true; and all statements made on information and belief are believed to be true.
