TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ( "Assignment") is made by and between Fedders North America, Inc., a Delaware corporation, located at 505 Martinsville Road, Liberty Corner New Jersey 07938 ("Assignor") and Airwell Hong Kong Technologies Limited, a Hong Kong company, located at 1401 Hutchison House, 10 Harcourt, Hong Kong ("Assignee"), as of the 14th day of March, 2008 ("Effective Date").

WHEREAS, Assignor is the owner of all right, title, interest, and goodwill in and to the trademarks set forth in the attached Appendix "A" (the "Marks"); and,

WHEREAS, Assignor entered into an certain Asset Purchase Agreement with Elco Holdings Ltd., a public Israeli corporation ("Elco"), dated as of February 8, 2008 (the "Purchase Agreement"), pursuant to which Elco agreed to purchase certain of the assets of of Assignor and Elco has assigned the right to purchase the the Marks to its affiliate company, the Assignee; and,

WHEREAS, the Assignee is desirous of acquiring ownership in all rights to the Marks of the Assignor as more fully described on Appendix "A"; and

WHEREAS, the Assignor is desirous of conveying ownership of the Marks to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency, and adequacy of which are hereby acknowledged, Assignor does hereby assign, sell, and transfer unto Assignee all of its right, title, and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, the right to sue for past infringement thereof, any registrations therefor, and all benefit of the Marks. Assignor does further consent to the recordation of this Agreement with any governmental agency.

Each Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing or vesting in Assignee full right, title and interest in the Assigned Rights.

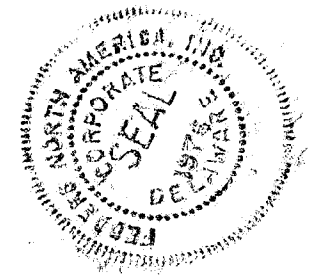


