(a Missouri General Partnership)

PARTNERSHIP AGREEMENT

This Partnership Agreement is effective as of the 29th day of September, 2006, by and between Emerson Power Transmission Bearings, Inc. and Emerson Power Transmission Drives and Components, Inc.

WITNESSETH:

WHEREAS, on December 19, 1997, Emerson Power Transmission Bearings, Inc., as General Partner, and Emerson Transmission Drives and Components, Inc., as Limited Partner, formed Emerson Power Transmission, L.P., a Missouri Limited Partnership;

WHEREAS, on March 27, 1998, the name of the Limited Partnership was changed to Emerson Power Transmission Manufacturing, L.P. (hereinafter the "Former Limited Partnership");

WHEREAS, as of the date hereof, Emerson Transmission Drives and Components, Inc., no longer desired to be treated as a limited partner and declared itself a partner under the Missouri Uniform Partnership Law;

WHEREAS, as of the date hereof, Emerson Transmission Drives and Components, Inc. converted its limited partnership interest into a general partnership interest in the Former Limited Partnership;

WHEREAS, on the date hereof, the Former Limited Partnership has filed a Certificate of Cancellation with the Secretary of State of Missouri, thereby canceling its Certificate of Limited Partnership, stating the reason for cancellation as that it no longer had any limited partners;

WHEREAS, the parties hereto desire to continue to carry on the business and affairs of the Former Limited Partnership as it existed prior to the termination of the limited partnership as a general partnership governed by Missouri law and without the limitations of liability afforded limited partners;

WHEREAS, upon cancellation of the Certificate of Limited Partnership, and thereby the termination of the Former Limited Partnership, the parties hereto continue their partnership (the "Partnership") under the Missouri Uniform Partnership Law for the purposes of continuing the business of the Former Limited Partnership;

WHEREAS, upon cancellation of the Certificate of Limited Partnership, the Partnership filed a Fictitious Name Statement for the Partnership with the Secretary of State of Missouri as required by Missouri law;

WHEREAS, the parties desire to operate the Partnership for the purposes and upon the terms herein stated;



ARTICLE TWO
FORMATION, NAME AND OFFICE, GENERAL CHARACTER,
TERM AND DISSOLUTION

2.1 Formation

The Partners formed a general partnership pursuant to the provisions of the Missouri Act upon the cancellation of the Certificate of Limited Partnership of the Former Limited Partnership.

2.2 Name, Business Address, Registered Office and Registered Agent

The Partnership shall be conducted under the name of "Emerson Power Transmission Manufacturing." The business address is 1248 East Second Street, Maysville, Kentucky, 41056-0687.


2.3 General Character of Business

The general character of business of the Partnership shall be (i) to manufacture or obtain and sell Products to Emerson Power Transmission Corp., an Affiliate of the Partnership, and (ii) to provide management services to certain of its Affiliates. The Partnership may engage in other activities related or incidental thereto. The Partnership shall not, without the consent of all the Partners, engage in any other business or activity.

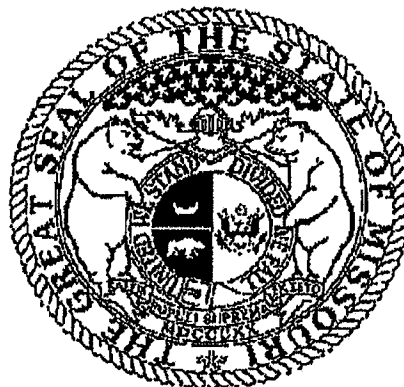


