**TERMINATION OF TRADEMARK SECURITY AGREEMENT**

WHEREAS, MicroStrategy Incorporated, a Delaware corporation, whose address is 1861 International Drive, McLean, Virginia 22102 and Strategy.com Incorporated, a Delaware corporation, whose address is 1861 International Drive, McLean, Virginia 22102 (the "Assignors") and Foothill Capital Corporation, a California corporation, whose address is 2450 Colorado Avenue, Santa Monica, California 90404 (the "Assignee"), entered into a certain Trademark Security Agreement (the "Security Agreement"), dated as of December 31, 2001, which was recorded in the United States Patent and Trademark Office on January 11, 2002 at Reel 2420 and Frame 0800, that by its terms granted the Assignee a security interest in certain intellectual property listed in Schedule A (the "Trademarks"); and
