Release of Lien on Trademarks

This Release of Lien on Trademarks (the "Release"), dated as of October 18, 2007, is made by Wells Fargo Bank, National Association ("Bank"), acting through its Wells Fargo Business Credit Operating Division, successor to Wells Fargo Business Credit, Inc., and assignee of Fleet Capital Corporation, successor to Summit Business Capital Corp., in favor of Heritage Brands, LLC, a New Jersey Limited Liability Company ("Grantor").

WHEREAS, Grantor entered into (a) a Patent and Trademark Security Agreement, dated as of February 10, 2006, and recorded in the United States Patent and Trademark Office (the "PTO") as of March 17, 2006, at Reel 003271, Frame 0097, and (b) a certain Trademark Collateral Assignment dated as of May 9, 2001 and recorded in the PTO as of May 14, 2001 at Reel 002304, Frame 0481, pursuant to which Grantor granted to the Bank a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Obligations have now been satisfied, Grantor has requested that the Bank release any and all interest it may have in the Released Trademarks, and the Bank has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Bank does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.
