SATISFACTION AND RELEASE

RE: ALABAMA SPACE SCIENCE EXHIBIT FINANCE AUTHORITY
SPACE SCIENCE EXHIBIT VARIABLE/FIXED RATE REVENUE
REFUNDING BONDS, SERIES 2005-A

The undersigned, Regions Bank, an Alabama banking corporation (the "Bank"), successor to AmSouth Bank in the capacity of Credit Obligor under a Letter of Credit Application and Reimbursement Agreement, dated as of May 1, 2005 (the "Credit Agreement"), between AmSouth Bank and ALABAMA SPACE SCIENCE EXHIBIT FINANCE AUTHORITY (the "Authority"), has assumed the obligations of AmSouth Bank under Letter of Credit No. 78318234 issued by AmSouth Bank (the "Letter of Credit") pursuant to the Credit Agreement in connection with the Authority's Space Science Exhibit Variable/Fixed Rate Revenue Refunding Bonds, Series 2005-A, dated May 26, 2005.

The undersigned does hereby acknowledge as follows: (i) U.S. Bank, National Association, as successor trustee under that certain Mortgage Indenture of the Authority dated as of May 1, 2005 (the "Indenture"), has delivered to the Bank a Certificate of Cancellation pursuant to paragraph 14(b) of the Letter of Credit; (ii) the Letter of Credit has been surrendered to the Bank and (iii) all obligations owed to the Bank by the Authority under the Credit Agreement have been paid in full.

The Bank hereby releases any rights, benefits and liens it has or may have in the Mortgaged Property (as defined in that certain Amended and Restated Mortgage, Leasehold Mortgage, Assignment of Rents and Leases, Security Agreement and Fixture Filing filed in the Office of the Judge of Probate of Madison County, Alabama, in Mortgage Book 2982 at Page 870, which amended and restated that certain Mortgage, Assignment of Rents and Leases and Security Agreement filed in the Office of the Probate Judge of Madison County, Alabama, in Mortgage Book 2744 at page 859, and in that certain Assignment of Rents and Leases filed in said office in Mortgage Book 2982 at Page 900) (together, the "Mortgages and Assignments"), and hereby reconveys, releases, assigns and delivers unto the Authority any and all of the estate, right, title and interest in and to any and all rights or property conveyed, mortgaged, assigned or pledged to or held by the Bank for its benefit pursuant to or otherwise subject to the lien of the Mortgages and Assignments.


