**TRADEMARK ASSIGNMENT**  
**(NUNC PRO TUNC)**

WHEREAS, J.A. Preston Corporation, a New York corporation, having its principal place of business at 500 Fillmore Avenue, Tonawanda, NY 14150 ("Assignor"), was the record owner of the entire right, title and interest in and to United States Trademark Registration No. 1,529,453 (for the mark JAMAR) (the "Trademark") beginning on December 15, 1988; and


WHEREAS J.A. Preston Corporation ("Assignor") officially changed its corporate name on July 27, 2005 to Medco Supply Company, Inc., a New York corporation, having its principal place of business at 500 Fillmore Avenue, Tonawanda, NY 14150 and was thereafter merged into Patterson Medical Supply, Inc., a Minnesota corporation having its principal place of business at 1000 Remington Boulevard, Bolingbrook, Illinois 60440 on April 28, 2007; and

WHEREAS, Assignor had agreed to assign and transfer its entire right, title and interest in and to the Trademark, together with all of the goodwill associated therewith and symbolized thereby, including all common law rights associated with the Trademark by virtue of its use in commerce, to Bissell Healthcare Corporation., a Michigan corporation, having its principal place of business at 2345 Walker Avenue, Grand Rapids, Michigan 49504 ("Assignee");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor, Assignor does hereby sell, convey, transfer and assign and deliver unto Assignee, its successors and assigns, the entire right, title and interest in and to the Trademark, together with the goodwill associated therewith and symbolized thereby, and in and to any and all renewals thereof, together with all rights to sue and recover for past infringement thereof, to have and to hold forever for the sole and exclusive use and benefit of Assignee, *nunc pro tunc*, now for then, effective as of January 12, 1998.
