**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
BRANTLEY SECURITY SERVICES, INC.**

Pursuant to the provisions of KRS 271B.10-030, the following Articles of Amendment to the Articles of Incorporation of **BRANTLEY SECURITY SERVICES, INC.** a Kentucky corporation ("Corporation"), are hereby adopted:

1. The name of the Corporation is **BRANTLEY SECURITY SERVICES, INC.**
2. Paragraph I of the Corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

**ARTICLE I**

The name of the Corporation shall be **BRANTLEY HOLDINGS, INC.**"

3. The amendment was adopted by the Corporation's Board of Directors by unanimous written consent effective as of December 29, 2006 and submitted for approval by the Corporation's shareholders who approved the amendment by unanimous written consent effective as of December 29, 2006.
4. The Corporation has outstanding 500 shares of Class A Voting Common Stock, no par value per share, each of which was entitled to one vote with respect to the amendment. All 500 votes were cast for the amendment which number was sufficient for approval of the amendment.
