ASSIGNMENT

THIS ASSIGNMENT is made this 11th day of July 2008
BETWEEN Crispin Systems Limited of Desford Hall, Leicester Lane, Desford,
Leicestershire, LE9 9JJ. (Company No. 04981601) (hereinafter called "the Assignor") of

WHEREAS:-

- (A) The Assignor is the Registered Proprietor of the Trade Mark Registration details of which are set out in the schedule hereto (hereinafter referred to as "the Trade Mark").
- (B) The Assignor has agreed to assign the Trade Mark to the Assignee for the consideration hereinafter appearing.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:-**1. Assignment**

In consideration of the sum of one pound (£1.00) now paid by the Assignee to the Assignor (the receipt whereof is hereby acknowledged by the Assignor), the Assignor hereby assigns with full title guarantee the Trade Mark and all right, title and interest therein together with the goodwill symbolised in the Trade Mark and together with all rights of action, remedies, powers and benefits relating to any of the Trade Mark including the right to sue for damages for infringement occurring before the date of this Assignment.

2. Further Assurance

The Assignor undertakes that, at the request and expense of the Assignee, it will execute all such documents, forms and authorisations and depose to or swear any declaration or oath as may be necessary under the law of any country for completing the transfer to the Assignee of the full right, title and interest to any of the rights assigned by Clause 1.

3. Applicable Law and Jurisdiction

This Assignment and any dispute or claim arising out of or in connection with it shall be governed by and construed in accordance with the laws of England and all disputes or claims arising out of or relating to this Assignment shall be subject to the exclusive jurisdiction of the English Courts to which the parties irrevocably submit.
